Project Startup	The Project Startup includes project management, system setup, configuration, and customization, and comprehensive staff training. Monthly Subscription	The Monthly Subscription covers use of the software, upgrades/enhancements at no additional cost, ongoing support, and practice care services	The monthly subscription fee is billed in advance and is based on the number of full time and part time equivalent providers (i.e. MDs, NPs, PAs, etc.) and includes software, support, and practice care services for all practice users associated with the providers.
Revenue Cycle Management (RCM)	RCM includes the use of the i3EHR software and includes additional outsourced services to manage the revenue cycle	RCM services are provided under a month to month service contract. The pricing for this service is typically inclusive of the i3EHR Monthly Subscription and is based on either the number of transactions or as a percentage of revenue collected.
Medication CPOE - Requirements 170.315(a)(1)	Ability for users to order, change, and review medications.	This functionality requires the use of a fully integrated e-prescribe module from a third party vendor. The license fee for this module is typically included in the i3EHR subscription license and therefore requires no additional fees

Laboratory CPOE - Requirement 107.315(a)(2)	Ability for users to to order, change, and review laboratory tests	There is no additional fee required to use this functionality. Optionally, electronic submission of lab orders are facilitated through integration with the 3rd party lab system. Integration services (and associated costs) are typically included in the Monthly Subscription Fee.
Radiology CPOE - Requirement 107.315(a)(3)	Ability to use computerized order capability to order radiology tests	There is no additional fee required to use this functionality. Optionally, electronic submission of radiology orders are facilitated through integration with the 3rd party radiology system. Integration services (and associated costs) are typically included in the Monthly Subscription Fee.
Drug-Drug, drug-allergy interaction checks for CPOE - Requirement 170.315(a)(4)	Ability to check for adverse drug or allergy interactions when ordering a new medication	This functionality requires the use of a fully integrated e-prescribe module from a third party vendor. The license fee for this module is typically included in the i3EHR subscription license and therefore requires no additional fees
Demographics - Requirement 170.315(a)(5)	Ability to record, edit, and review specific demographic data associated with each patient.	There is no additional fee required to use this functionality
Problem List - Requirement 170.315(a)(6)	Ability to record, edit, and review the active problem list associated with each patient.	There is no additional fee required to use this functionality
Medication List - Requirement 170.315(a)(7)	Ability to record, edit, and review the active medication list and medication history associated with each patient.	This functionality requires the use of a fully integrated e-prescribe module from a third party vendor. The license fee for this module is typically included in the i3EHR subscription license and therefore requires no additional fees
Medication Allergy List - Requirement 170.315(a)(8)	Ability to record, edit, and review the active medication allergy list and medication allergy	This functionality requires the use of a fully integrated e-prescribe module from a third

Clinical Decision Support (CDS) - Requirement 170.315(a)(9)	Clinic Decision Support indications provided to clinical/admin users based on the specific patient's clinical data (i.e. med list, demographic, lab results, etc.)	i3EHR relies on a 3rd party application to provide the CDS intervention information/data. There is no additional fee required to use this functionality
Drug Formulary - Requirement 170.315(a)(10)	Automatically checks whether a drug formulary exists for the patient and/or a specific medication.	This functionality requires the use of a fully integrated e-prescribe module from a third party vendor. The license fee for this module is typically included in the i3EHR subscription license and therefore requires no additional fees
Smoking Status - Requirement 170.315(a)(11)	Ability to record, change, and review the smoking status of a patient.	There is no additional fee required to use this functionality
Family Health History - Requirement 170.315(a)(12)	Ability to record, change, and review family health history of a patient	There is no additional fee required to use this functionality
Patient Specific Education Resources - Requirement 170.315(a)(13)	Ability to electronically provide patient educational information specific to each patient based on their unique clinical and demographic information.	i3EHR relies on a 3rd party application to provide the educational information/data. There is no additional fee required to use this functionality
Implantable Device List - Requirement 170.315(a)(14)	Ability to record and display information about patient specific implantable devices based on Unique Device Identifier	i3EHR relies on a 3rd party application to provide certain device information. There is no additional fee required to use this functionality
Social, psychological, and behavior data - Requirement 170.315(a)(15)	Ability to record social, psychological, and behavior information as structured data within the patient record.	There is no additional fee required to use this functionality
Transition of Care - Requirement	Ability to create, send, receive, validate, and	Providers can send transition of care

Clinical Information Reconciliation - Requirement 170.315(b)(2)	Ability to associate an incoming CCD or Referral document to the applicable patient and reconcile and incorporate clinical data into that patient's medical record based on discrete data available in the incoming CCD document.	To receive CCD documents from other providers of care requires the provider to have a Secure Direct Address provisioned by a third party. There is a one time setup fee and an annual, per provider maintenance fee associated with these addresses.
Electronic Prescribing - Requirement 170.315(b)(3)	Ability to Electronically: transmit new prescriptions, change prescriptions, cancel prescriptions, refill prescriptions, and request and receive medication history information.	This functionality requires the use of a fully integrated e-prescribe module from a third party vendor. The license fee for this module is typically included in the i3EHR subscription license and therefore requires no additional fees
Data Export - Requirement 170.315(b)(6)	Ability for a user to create and export a set of CCD documents based on user entered criteria to determine the set of patients.	There is no additional fee required to use this functionality
Clinical Quality Measures (CQMs) - Requirements 170.315(c)(1-4)	Ability for the user to record & export, import and calculate, report, and filter eCQM data	i3EHR relies on a third party application to support this functionality. There is an additional fee per provider per year to support these functions.
Technical & Security Related Functions - Requirements 170.315(d)(1-10)	Ability to authenticate users, audit use, and manage access and data encryption	There is no additional fee required to use this functionality
View, Download, and Transmit to 3rd Party -	Ability for patients to use internet-based	This functionality requires the use of the

Secure Messaging - Requirement 170.315(e)(2)	Ability for clinic users to send secure messages to patients, patients to review clinic messages sent, patients to send secure messages to clinic users, and clinic users to review messages received by patients.	This functionality requires the use of the i3EHR Patient Portal which is a module included at no additional charge.
Patient Health Information Capture - Requirement 170.315(e)(3)	Ability for clinic users to identify, record, and access information directly and electronically shared by a patient and reference and link to the patient health information documents.	There is no additional fee required to use this functionality
Public Health Reporting - Requirements 170.315(f)(1-2, 4-5)	Ability to submit data to public health registries	i3EHR relies on a third party application to support these requirements. There is an additional fee to support these requirements that is based on the number of providers and is either a monthly or annual license fee.
Automated Numerator Recording - Requirement 170.315(g)(1)	A report for all percentage based measures to review the patients or actions that would make the patient or action eligible to be included in the measures numerator.	There is no additional fee required to use this functionality
Automated Measure Calculation - Requirement 170.315(g)(2)	Record the numerator & denominator for each percentage based measure that is supported by a capability included in the technology and create a report including the numerator, denominator, and resulting percentage associated with each applicable measure.	There is no additional fee required to use this functionality
Safety Enhanced Design, Quality Management System, Accessibility Centered Design	Internal development processes and protocols in place to ensure safety, quality, and accessible designs.	There is no additional fee required to use this functionality
Consolidated CDA Creation - Requirement 170.315(g)(6)	Ability to create a Consolidated CDA per required standards	There is no additional fee required to use this functionality

<p>Direct Project, Edge Protocol, and XDR/XDM - Requirement 170.315(h)(2)</p>	<p>Ability to send and receive health information according to required standards and technical protocols.</p>	<p>i3EHR relies on a 3rd party application to support this requirement. The 3rd party application is used for the provision and maintenance of secure direct addresses. There is a one time setup fee and annual maintenance fee associated with each provider who requires use of a Secure Direct Address to send and receive patient health information with other providers of care.</p>
